

WHAT PRACTITIONERS NEED TO KNOW ABOUT INTERSTATE CUSTODY AND RELOCATION MATTERS

Imagine Madison, a mother of two, who finally lands a life-changing job in a neighboring state. She is very excited that her life is changing for the better--she just finished the court process of securing a protection order that gives her custody of her children for two years. This is an opportunity that offers financial security and a fresh start away from her abusive partner. But with this excitement for the future, comes a critical question:

### Can she take her children with her?

For survivors of domestic violence, relocating isn't as simple as finding a new place to live. When children are involved, crossing state lines can trigger a maze of legal issues. Each state has its own custody laws and navigating them can feel overwhelming. Without the right legal steps, a survivor risks not only her safety, and/or criminal charges, but also the ability to stay with her children.

In some situations, leaving a state with children, without the proper court authorization, could be considered unlawful, even if done for safety reasons. When faced with these situations survivors need to know if they can relocate with their children, if their protection order will be enforced in that neighboring state, what legal actions can the abusive partner take if the survivor does leave, how custody in the protection order intersects with a permanent custody case, and so much more.

To support attorneys and advocates working with survivors seeking to relocate, the National Center on Protection Orders and Full Faith & Credit (NCPOFFC) has created a series of tools to help navigate these complex legal waters.

# **The Interstate Custody Tool Series**

This resource provides guidance on how federal and state laws intersect in custody cases that cross state or tribal lines. It covers essential topics, including:

**Frequently Asked Questions (FAQ):** Answers to common questions about interstate custody laws.

<u>VAWA – A Practitioner's Guide:</u> How the Violence Against Women Act (VAWA) including the full faith and credit provision of VAWA impacts custody matters.

<u>UCCJEA – A Practitioner's Guide:</u> The Uniform Child Custody Jurisdiction Enforcement Act determines which state has the jurisdiction to issue or change a custody order.
