Summary

This matrix provides every state and U.S. territory's definition of domestic violence/ abuse and the relationships that qualify for relief. The column to the left lists the states and territories alphabetically. The right column provides the definition of domestic violence or abuse and outlines the qualifying relationships for a domestic violence civil protection order. The definitions of abuse vary from state to state. There are, however, some similarities in the actions that are considered abusive in all of the statutes. Physical violence and the threat of physical violence are included in every state's statute. At the same time, some states are very precise in their definitions of abuse regarding the physical and non-physical actions that abuse is composed of and the parties that are involved; other states include only basic definitions that are more open to broad interpretation.

Sexual Assault:

Twenty-four states, one territory. and the District of Columbia mention sexual assault in their statutes and specifically defines sexual assault by reference to another statute. (Alabama, Alaska, Arizona, Arkansas, Delaware, District of Columbia (refers to crimes in general), Maine, Maryland, Minnesota, Mississippi, Montana, Nebraska, New Hampshire, New Jersey, New York, North Carolina, Ohio, Oklahoma, South Carolina, South Dakota, Tennessee, Vermont, Virgin Islands, West Virginia, Wisconsin, and Wyoming). Ten states mention or include sexual assault within their statutes. (California, Florida, Idaho, Illinois, Kentucky, Louisiana, Nevada, New Mexico, Texas, and Virginia.) Ten states and two territories define sexual assault in their statutes (American Samoa, Colorado, Indiana, Kansas, Massachusetts, Missouri, North Dakota, Northern Mariana Islands, Oregon, Pennsylvania, Rhode Island, and Washington).

Stalking and Harassment:

Twenty-nine jurisdictions include stalking within their definitions of abuse (Alabama, Arizona, California, Colorado, Connecticut, Florida, Georgia, Indiana, Kentucky, Maine Maryland, Mississippi, Missouri, Montana, Nevada, New Jersey, New Mexico, New York, Oklahoma, Pennsylvania, Rhode Island, South Dakota, Tennessee, Utah, Vermont, Virgin Islands, Virginia, Washington, and West Virginia). Seventeen states and two territories recognize various forms of harassment as abusive (Alabama, Alaska, Arizona, California, Connecticut, Illinois, Missouri, New Hampshire, New Jersey, New Mexico, New York, North Carolina, the Northern Mariana Islands, Oklahoma, Rhode Island, Utah, the Virgin Islands, Washington, and West Virginia).

Cyber-stalking and Harassment:

As technology changes and advances, so do methods of abuse. Some states have included cyber-stalking and harassment via technology in defining abuse. As of 2024, Mississippi, New Jersey, Utah, Rhode Island, and Washington include cyber abuse or stalking in their statutory definitions of abuse. In California, New Mexico, and Oklahoma the definition of abuse includes harassment via telephone calls.

Pet Abuse:

Abuse against animals as part of the definition of domestic violence is becoming more frequent in statutes. A number of juris dictions include violence towards household animals in their definitions of abuse (Alaska, Arizona, Colorado, Connecticut, Delaware, the District of Columbia, Indiana, Kentucky, Massachusetts, Michigan, Missouri, Nevada, New Hampshire, Utah, and Wisconsin).

Sex Trafficking & Distribution of Intimate Images:

Sex trafficking, defined by the U.S. Department of Justice, is the recruitment, harboring, transportation, provision, obtaining, patronizing, or soliciting of a person for the purpose of a commercial sex act in which a commercial sex act is induced by force, fraud, or coercion, or in which the person induced to perform such act has not attained 18 years of age. Only two jurisdictions include sex trafficking in their definitions of abuse--Maine and Montana. Eight states and one territory added the distribution of intimate images to their definition of abuse—some calling it revenge porn and others adding this act to their definition of coercive control. (Arizona, Connecticut, Maine, Maryland, Massachusetts, New York, Vermont, Virgin Islands, and Washington).

Coercion:

Seventeen states and territories include and/or mention coercion or coercive control in their definitions of domestic violence and abuse. (Alabama, California, Colorado, Connecticut, Delaware, Hawaii, Kentucky, Maine, Massachusetts, Missouri, Nevada, New Jersey, New York, Tennessee, U.S. Virgin Islands, Vermont and Washington.

Dating Relationship:

While every state, territory and the District of Columbia includes some definition of romantic, spouse, or intimate partner relationship, some states have a specific provision for a "Dating Relationship" or an "Intimate Relationship" that does not require cohabitation. These provisions often explicitly state that they do not include "casual" or "ordinary business" relationships. These statutes also give the courts discretion to determine the existence of a dating relationship based on the length, nature, frequency, and date of termination of the relationship. Thirty-three states define dating relationships in their definitions of qualifying relationships for domestic violence civil protection orders. (Alabama, Arkansas, Arizona, California, Delaware, Georgia, Hawaii, Idaho, Illinois, Iowa, Kansas, Kentucky, Louisiana, Maine, Massachusetts, Michigan, Mississippi, Nebraska, Nevada, North Carolina, New Hampshire, New Mexico, New York, Ohio, Oklahoma, Rhode Island, South Dakota, Tennessee, Texas, Utah, Vermont, Washington, and Wisconsin.) Seventeen jurisdictions include and/or mention dating relationships in their statute (Alaska, American Samoa, Connecticut, District of Columbia, Colorado, Guam, Indiana, Minnesota, Montana, Northern Mariana Islands, Pennsylvania, Puerto Rico, New Jersey, North Dakota, Virgin Islands West Virginia, and Wyoming). Only five states fail to include either of these two terms when defining qualifying relationships (Florida, Maryland (includes sexual relationships only), Minnesota, South Carolina, and Virginia).

§ 30-5-2

In this chapter, the following words have the following meanings unless the context clearly indicates otherwise:

- (1) Abuse. An act committed against a victim, which is any of the following:
- **a. Arson.** Arson as defined under Sections 13A-7-40 to 13A-7-43, inclusive.
- **b. Assault.** Assault as defined under Sections 13A-6-20 to 13A-6-22, inclusive.
- c. Attempt. Attempt as defined under Section 13A-4-2.
- **d. Child Abuse.** Torture or willful abuse of a child, aggravated child abuse, or chemical endangerment of a child as provided in Chapter 15, commencing with Section 26-15-1, of Title 26, known as the Alabama Child Abuse Act.
- e. Criminal Coercion. Criminal coercion as defined under Section 13A-6-25.
- **f. Criminal Trespass.** Criminal trespass as defined under Sections 13A-7-2 to 13A-7-4.1, inclusive.
- **g. Harassment.** Harassment as defined under Section 13A-11-8.
- **h. Kidnapping.** Kidnapping as defined under Sections 13A-6-43 and 13A-6-44.
- i. Menacing. Menacing as defined under Section 13A-6-23.
- **j. Other Conduct.** Any other conduct directed toward a plaintiff covered by this chapter could be punished as a criminal act under the laws of this state.
- k. Reckless Endangerment. Reckless endangerment as defined under Section 13A-6-24.
- **l. Sexual Abuse.** Any sexual offenses included in Article 4, commencing with Section 13A-6-60, of Chapter 6 of Title 13A.
- m. Stalking. Stalking as defined under Sections 13A-6-90 to 13A-6-94, inclusive.
- **n. Theft.** Theft as defined under Sections 13A-8-1 to 13A-8-5, inclusive.
- **o.** Unlawful Imprisonment. Unlawful imprisonment as defined under Sections 13A-6-41 and 13A-6-42.
- **(3) Dating relationship.** A relationship or former relationship of a romantic or intimate nature characterized by the expectation of affectionate or sexual involvement by either party.
- **a.** A dating relationship includes the period of engagement to be married.
- **b.** A dating relationship does not include a casual or business relationship or a relationship that ended more than 12 months prior to the filing of the petition for a protection order.

- (4) Plaintiff. An individual who has standing to file a petition under Section 30-5-5.
- **(6) Threat.** Any word or action, expressed or implied, made to cause the plaintiff to fear for his or her safety or for the safety of another person.
- (7) Victim. An individual who is related in any of the following ways to the person who commits an act of abuse:
- **a.** Has a current or former marriage, including common law marriage, with the defendant.
- **b.** Has a child in common with the defendant regardless of whether the victim and defendant have ever been married and regardless of whether they are currently residing or have in the past resided together in the same household.
- **c.** Has or had a dating relationship with the defendant. A dating relationship does not include a casual or business relationship or a relationship that ended more than 12 months prior to the filing of the petition for a protection order.
- **d.** Is a current or former household member. For purposes of this chapter, a "household member" excludes non-romantic or non-intimate co-residents.
- **e.** A relative of a current or former household member as defined in paragraph d. who also lived with the defendant.
- **f.** An individual who is a parent, stepparent, child, or stepchild.
- g. An individual who is a grandparent, step-grandparent, grandchild, or step-grandchild.

- (3) "domestic violence" and "crime involving domestic violence" mean one or more of the following offenses or an offense under a law or ordinance of another jurisdiction having elements similar to these offenses, or an attempt to commit the offense, by a household member* against another household member:
 - A. a crime against the person under AS 11.41;
 - B. burglary under AS 11.46.300 -- 11.46.310;
 - C. criminal trespass under AS 11.46.320 -- 11.46.330;
 - D. arson or criminally negligent burning under AS 11.46.400 -- 11.46.430;
 - E. criminal mischief under AS 11.46.475 -- 11.46.486;
 - F. terrorist threatening under AS 11.56.807 or 11.56.810;
 - G. violating a protective order under AS 11.56.740(a)(1);
 - H. harassment under AS 11.61.120(a)(2) (4) or (6);
 - I. or cruelty to animals under AS 11.61.140(a)(5) if the animal is a pet;
 - J. interfering with a report of a crime involving domestic violence under AS 11.56.745 if the person interfering with the report is the person who committed the underlying crime involving domestic violence; or
 - K. unlawful contact under AS 11.56.750 or 11.56.755;

(5) "household member" includes

- A. adults or minors who are current or former spouses;
- B. adults or minors who live together or who have lived together;
- C. adults or minors who are dating or who have dated;
- D. adults or minors who are engaged in or who have engaged in a sexual relationship;
- E. adults or minors who are related to each other up to the fourth degree of consanguinity, whether of the whole or half blood or by adoption, computed under the rules of civil law;
- F. adults or minors who are related or formerly related by marriage;
- G. persons who have a child of the relationship; and

A. "Domestic violence" means any act that is a dangerous crime against children as defined in section 13-705 [Dangerous crimes against children] or an offense prescribed in section 13-1102 [Negligent homicide], 13-1103 [Manslaughter], 13-1104 [Second degree murder], 13-1105 [First degree murder], 13-1201 [Endangerment], 13-1202 [Threatening or intimidating], 13-1203 [Assault], 13-1204 [Aggravated assault], 13-1302 [Custodial interference], 13-1303 [Unlawful imprisonment], 13-1304 [Kidnapping], 13-1406 [Sexual assault], 13-1425 [Unlawful disclosure of images depicting states of nudity or specific sexual activities], 13-1502 [Criminal trespass in the third degree], 13-1503 [Criminal trespass in the second degree], 13-1504 [Criminal trespass in the first degree], 13-1602 [Criminal damage] or 13-2810 [Interfering with judicial proceedings], section 13-2904 [Disorderly conduct], subsection A, paragraph 1, 2, 3 or 6, section 13-2910 [Cruelty to animals], subsection A, paragraph 8 or 9, section 13-2915 [Preventing use of telephone in emergency], subsection A, paragraph 3 or section 13-2916 [Use of an electronic communication to terrify, intimidate, threaten or harass], 13-2921 [Harassment], 13-2921.01 [Aggravated harassment], 13-2923 [Stalking], 13-3019 [Surreptitious photographing, videotaping, filming or digitally recording or viewing], 13-3601.02 [Aggravated domestic violence] or 13-3623 [Child or vulnerable adult abuse; emotional abuse], if any of the following applies:

- 1. The relationship between the **victim and the defendant** is one of marriage or former marriage or of persons residing or having resided in the same household.
- 2. The victim and the defendant have a child in common.
- 3. The **victim or the defendant** is pregnant by the other party.
- 4. The **victim is related to the defendant** or the defendant's spouse by blood or court order as a parent, grandparent, child, grandchild, brother or sister or by marriage as a parent-in-law, grandparent-in-law, stepparent, step-grandparent, stepchild, step-grandchild, brother-in-law or sister-in-law.
- 5. The **victim is a child** who resides or has resided in the same household as the defendant and is related by blood to a former spouse of the defendant or to a person who resides or who has resided in the same household as the defendant.

- (3)(A) "Dating relationship" means a romantic or intimate social relationship between two (2) individuals that shall be determined by examining the following factors:
 - (i) The length of the relationship;
 - (ii) The type of the relationship; and
 - (iii) The frequency of interaction between the two (2) individuals involved in the relationship.
- (B) "Dating relationship" does not include a casual relationship or ordinary fraternization between two (2) individuals in a business or

social context;

- (4) "Domestic abuse" means:
- (A) Physical harm, bodily injury, assault, or the infliction of fear of imminent physical harm, bodily injury, or assault between family or

household members; or

(B) Any sexual conduct between family or household members, whether minors or adults, that constitutes a crime under the laws of

this state;

- (5) "Family or household members" means spouses, former spouses, parents and children, persons related by blood within the fourth degree of consanguinity, in-laws, any children residing in the household, persons who presently or in the past have resided or cohabited together, persons who have or have had a child in common, and persons who are presently or in the past have been in a dating relationship together;
- (6) "In-laws" means persons related by marriage within the second degree of consanguinity;

§ 6203. "Abuse"

- (a) For purposes of this act, "abuse" means any of the following:
 - 1. To intentionally or recklessly cause or attempt to cause bodily injury.
 - 2. Sexual assault.
 - 3. To place a person in reasonable apprehension of imminent serious bodily injury to that person or to another.
 - 4. To engage in any behavior that has been or could be enjoined pursuant to Section 6320.*
- **(b)** Abuse is not limited to the actual infliction of physical injury or assault.

§ 6320. Enjoining harassment, threats, and violence*

- (a) The court may issue an ex parte order enjoining a party from molesting, attacking, striking, stalking, threatening, sexually assaulting, battering, credibly impersonating as described in Section 528.5 of the Penal Code, falsely personating as described in Section 529 of the Penal Code, harassing, telephoning, including, but not limited to, making annoying telephone calls as described in Section 653m of the Penal Code, destroying personal property, contacting, either directly or indirectly, by mail or otherwise, coming within a specified distance of, or disturbing the peace of the other party, and, in the discretion of the court, on a showing of good cause, of other named family or household members.
- (c) As used in this subdivision (a), "disturbing the peace of the other party" refers to conduct that, based on the totality of the circumstances, destroys the mental or emotional calm of the other party. This conduct may be committed directly or indirectly, including through the use of a third party, and by any method or through any means including, but not limited to, telephone, online accounts, text messages, internet-connected devices, or other electronic technologies. This conduct includes, but is not limited to, coercive control, which is a pattern of behavior that in purpose or effect unreasonably interferes with a person's free will and personal liberty. Examples of coercive control include, but are not limited to, unreasonably engaging in any of the following:

- 1. Isolating the other party from friends, relatives, or other sources of support.
- 2. Depriving the other party of basic necessities.
- 3. Controlling, regulating, or monitoring the other party's movements, communications, daily behavior, finances, economic resources, or access to services.
- 4. Compelling the other party by force, threat of force, or intimidation, including threats based on actual or suspected immigration status, to engage in conduct from which the other party has a right to abstain or to abstain from conduct in which the other party has a right to engage.
- 5. Engaging in reproductive coercion, which consists of control over the reproductive autonomy of another through force, threat of force, or intimidation, and may include, but is not limited to, unreasonably pressuring the other party to become pregnant, deliberately interfering with contraception use or access to reproductive health information, or using coercive tactics to control, or attempt to control, pregnancy outcomes.

§ 6211. "Domestic violence"

"Domestic violence" is abuse perpetrated against any of the following persons:

- a. A spouse or former spouse.
- b. A **cohabitant**** or former cohabitant, as defined in Section 6209.
- c. A person with whom the respondent is having or has had a dating or engagement relationship.***
- d. A person with whom the respondent has had a child, where the presumption applies that the male parent is the father of the child of the female parent under the Uniform Parentage Act (Part 3 (commencing with Section 7600) of Division 12).
- e. A child of a party or a child who is the subject of an action under the Uniform Parentage Act, where the presumption applies that the male parent is the father of the child to be protected.
- f. Any other person related by consanguinity or affinity within the second degree.

§ 6301. Persons who may be granted restraining order

(b) An order under this part may be granted to any person described in Section 6211, including a minor pursuant to subdivision (b) of Section 372 of the Code of Civil Procedure.

- **2) "Domestic abuse"** means any act, attempted act, or threatened act of violence, stalking, harassment, or coercion that is committed by any person against another person to whom the actor is currently or was formerly related, or with whom the actor is living or has lived in the same domicile. **"Domestic abuse"** may also include any act, attempted act, or threatened act of violence against:
- (a) The **minor children** of either of the parties; or
- (b) An **animal** owned, possessed, leased, kept, or held by either of the parties or by a minor child of either of the parties, which threat, act, or attempted act is intended to coerce, control, punish, intimidate, or exact revenge upon either of the parties or a minor child of either of the parties.

- (2.9) "Sexual violence" means an unwanted or nonconsensual sexual behavior, act or attempted act, or threatened act, including, but not limited to, unlawful sexual behavior, as described in section 16-11.7-102 (3), by a person against another person, regardless of the relationship between the actor and the petitioner.
- (3) "Stalking" means any act, attempted act, or threatened act of stalking as described in section 18-3-602, C.R.S.

- (5) Threatening to harm or kill the individual or a child or relative of the individual;
- (6) Threatening to publish information or make reports to the police or the authorities;
- (7) Damaging property or household goods; and
- (8) Forcing the individual to take part in criminal activity or child abuse.

"Dating relationship" means a romantic, courtship, or engagement relationship, often but not necessarily characterized by actions of an intimate or sexual nature, but does not include a casual acquaintanceship or ordinary fraternization between persons in a business or social context.

"Domestic abuse" means:

- (1) Physical harm, bodily injury, assault, or the threat of imminent physical harm, bodily injury, or assault, extreme psychological abuse, coercive control, or malicious property damage between **family or household members***; or
- (2) Any act which would constitute an offense under section 709-906, or under part V or VI of chapter 707 committed against a minor family or household member by an adult family or household member.

"Extreme psychological abuse" means an intentional or knowing course of conduct directed at an individual that seriously alarms or disturbs constantly or continually bothers the individual, and that serves no legitimate purpose; provided that such course of conduct would cause a reasonable person to suffer extreme emotional distress.

Unless the presumption is rebutted by a preponderance of the evidence, the following types of conduct shall be presumed to cause emotional distress:
 - i. creating a disturbance at petitioner's place of employment or school;
 - ii. repeatedly telephoning petitioner's place of employment, home or residence;
- iii. repeatedly following petitioner about in a public place or places;

The family court and the criminal courts shall have concurrent jurisdiction over any proceeding concerning acts which would constitute disorderly conduct, unlawful dissemination or publication of an intimate image, harassment in the first degree, harassment in the second degree, aggravated harassment in the second degree, sexual misconduct, forcible touching, sexual abuse in the third degree, sexual abuse in the second degree as set forth in subdivision one of section 130.60 of the penal law, stalking in the first degree, stalking in the second degree, stalking in the third degree, stalking in the fourth degree, criminal mischief, menacing in the second degree, menacing in the third degree, reckless endangerment, criminal obstruction of breathing or blood circulation, strangulation in the second degree, strangulation in the first degree, assault in the second degree, assault in the third degree, an attempted assault, identity theft in the first degree, identity theft in the second degree, identity theft in the third degree, grand larceny in the fourth degree, grand larceny in the third degree, coercion in the second degree or coercion in the third degree as set forth in subdivisions one, two and three of section 135.60 of the penal law between spouses or former spouses, or between parent and child or between members of the same family or household except that if the respondent would not be criminally responsible by reason of age pursuant to section 30.00 of the penal law, then the family court shall have exclusive jurisdiction over such proceeding. Notwithstanding a complainant's election to proceed in family court, the criminal court shall not be divested of jurisdiction to hear a family offense proceeding pursuant to this section. In any proceeding pursuant to this article, a court shall not deny an order of protection, or dismiss a petition, solely on the basis that the acts or events alleged are not relatively contemporaneous with the date of the petition, the conclusion of the fact-finding or the conclusion of the dispositional hearing. For purposes of this article, "disorderly conduct" includes disorderly conduct not in a public place. For purposes of this article, "members of the same family or household" shall mean the following:

- (a) persons related by consanguinity or affinity;
- (b) persons legally married to one another;
- (c) persons formerly married to one another regardless of whether they still reside in the same household;
- (d) persons who have a child in common regardless of whether such persons have been married or have lived together at any time;

- (C) Carrying, exhibiting, displaying, drawing, or threatening to use, any firearm or any other weapon apparently capable of producing bodily harm, in a manner, under circumstances, and at a time and place that either manifests an intent to intimidate the other party or that warrants alarm by the other party for their safety or the safety of other persons;
- (D) Driving recklessly with the other party or minor children in the vehicle;
- (E) Communicating, directly or indirectly, the intent to:
- (I) Harm the other party's children, family members, friends, or pets, including by use of physical forms of violence;
- (II) Harm the other party's career;
- (III) Attempt suicide or other acts of self-harm; or
- (IV) Contact local or federal agencies based on actual or suspected immigration status;
- (F) Exerting control over the other party's identity documents;
- (G) Making, or threatening to make, private information public, including the other party's sexual orientation or gender identity, medical or behavioral health information, or other confidential information that jeopardizes safety; or

- (iii) Depriving the other party of basic necessities or committing other forms of financial exploitation;
- (iv) Controlling, exerting undue influence over, interfering with, regulating, or monitoring the other party's movements, communications, daily behavior, finances, economic resources, or employment, including but not limited to interference with or attempting to limit access to services for children of the other party, such as health care, medication, child care, or school-based extracurricular activities;
- (v) Engaging in vexatious litigation or abusive litigation as defined in RCW 26.51.020 against the other party to harass, coerce, or control the other party, to diminish or exhaust the other party's financial resources, or to compromise the other party's employment or housing; or
- (vi) Engaging in psychological aggression, including inflicting fear, humiliating, degrading, or punishing the other party.
- (b) "Coercive control" does not include protective actions taken by a party in good faith for the legitimate and lawful purpose of protecting themselves or children from the risk of harm posed by the other party.
- (7) (a) "Course of conduct" means a pattern of conduct composed of a series of acts over a period of time, however short, evidencing a continuity of purpose. "Course of conduct" includes any form of communication, contact, or conduct, including the sending of an electronic communication, but does not include constitutionally protected free speech. Constitutionally protected activity is not included within the meaning of "course of conduct."
- (b) In determining whether the course of conduct serves any legitimate or lawful purpose, a court should consider whether:
- (i) Any current contact between the parties was initiated by the respondent only or was initiated by both parties;
- (ii) The respondent has been given clear notice that all further contact with the petitioner is unwanted;
- (iii) The respondent's course of conduct appears designed to alarm, annoy, or harass the petitioner;
- (iv) The respondent is acting pursuant to any statutory authority including, but not limited to, acts which are reasonably necessary to:
- (A) Protect property or liberty interests;
- (B) Enforce the law; or

- (15) "Financial exploitation" means the illegal or improper use of, control over, or withholding of, the property, income, resources, or trust funds of the vulnerable adult by any person or entity for any person's or entity's profit or advantage other than for the vulnerable adult's profit or advantage. "Financial exploitation" includes, but is not limited to:
 - (a) The use of deception, intimidation, or undue influence by a person or entity in a position of trust and confidence with a vulnerable adult to obtain or use the property, income, resources, government benefits,

Evidence of emission of semen is not required to prove sexual penetration. (35) "Stalking" means any of the following:

- (j) Persecution. -- Shall mean keeping a person under constant or frequent surveillance by their presence in places that are immediate or relatively near to the home, residence, school, work or vehicle in which the person is, to cause fear or dread in the animus of a prudent and reasonable person.
- (m) Intimate relationship.— Shall mean the relationship between spouses, former spouses, persons who are cohabiting or have cohabited, persons who have or have had a consensual relationship, and persons who share a child in common, regardless of the sex, civil status, sexual orientation, gender identity, or the immigrant status of the persons involved in the relationship.
- (p) Domestic abuse. Shall mean a constant pattern of conduct involving physical force or psychological violence, intimidation or persecution against a person by his/her spouse, former spouse, a person with whom he/she cohabits or has cohabited, with whom he/she has or has had a consensual relationship, or a person with whom he/she shares a child in common, regardless of the sex, civil status, sexual orientation, gender identity, or the
