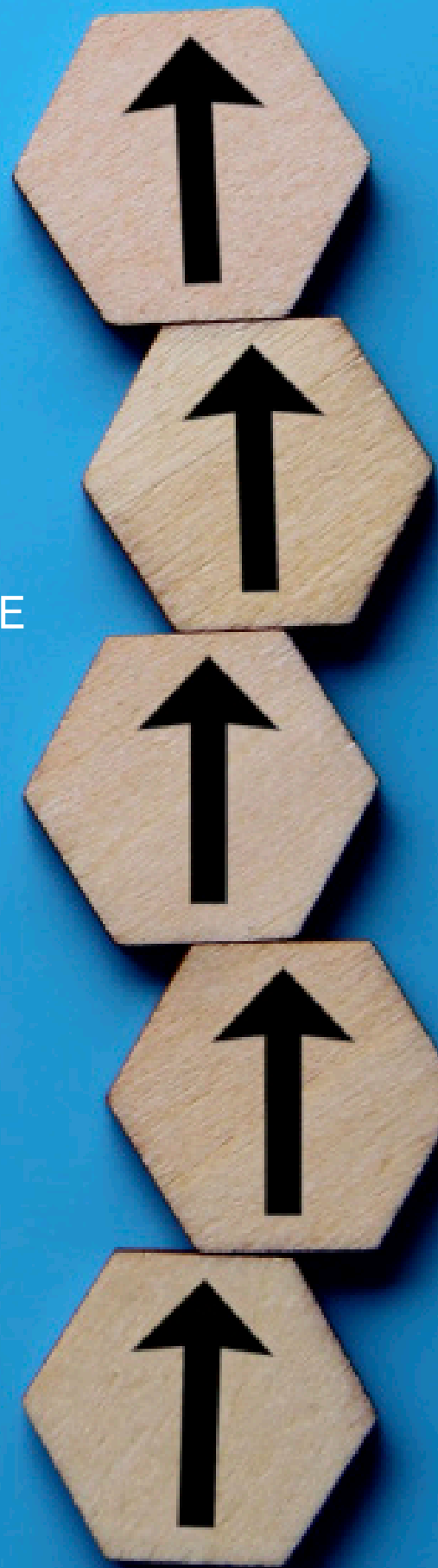

You have rights

Survivors of domestic violence often face significant economic challenges. You deserve access to resources such as safe housing, employment opportunities, and economic resources for yourself and any family members.

Surviving from day to day, struggling to make ends meet, experiencing abuse, and starting over can be frightening. Trust in your right to be safe and in the wisdom and resourcefulness that have helped you survive.

There is support

You are the expert on your life. And, you don't have to do it alone. Trained advocates, community-based organizations, culturally-specific organizations and financial institutions can support you, and advocate for and with you.
